 - a. Website Report Back

The new website is now 'live' and apparently working, run via a CMS. eGrad will be going through the new system, though a 'glitch' meant a temporary solution was sought at one point, costing \$50. The University deleted the old site, though a backup is being tracked for resources. Final cost is approximately \$20,000, and Paolo has copies of all documentation if necessary.

b. Emissions Reduction Working Group

The working group is redeveloping existing policy and working on reducing carbon dioxide emissions. The University is currently behind world standards and has recognised this fact.

12. Green Paper

John Nowakowski reviewed the documents in the Green Paper section, including a submission on Childcare from Sophia Barnes. Nick Irving reviewed Section 6 of the Green Paper submission

Ashlesha arrives, 6.05pm

Comments were made by Council that the APA may be government restricted, that teaching at the University is inequitable, that there is a lack of training for effective teaching, and that SUPRA has a policy on Casual Teaching. The Chair proposed that the policy be appended to the submission.

Nick Irving responded to the comments. The Chair spoke to Section 13 of the submission. Concerns were raised that the target levels set forth in Section 13 were unclear and needed clarification.

The Chair spoke to Section 4 of the submission, and feels that SUPRA should push for co-operative, and not privately-run student housing. Comments were made that there is a

need to address affordability, and a general opposition to University-owned housing. The Chair spoke to Section 11 of the submission. Comments were made that consideration needs to be granted for the workloads for International Students as well as Part-time students with limited resources. The Chair spoke to Section 2 of the submission. Comments were made that the Green Paper implicitly holds numbers constant and moves towards more Research students. Council feels that University should be put forth as a right, not a privilege for students, and that SUPRA opposes fees and limiting students. A cap should be put forth on High SES students, not just meeting a target for Low SES students. Accessibility is critical, and a link should be made between the green paper and these statements. The Chair spoke to Section 9 of the submission, and noted that clarification is needed on what "a portion of the Teaching and Learning Budget" is. Further, the University needs to recognise that the USU has improved services in recent years and the autonomy of the Student Associations on campus. Administration and Maintenance need to be separated from Governance, and disassembling the Union does not address issues.
